
Undertaking

- Fee revision will always be subject to laws, regulation and directions of the appropriate government.
- Fee will not be revised without the express approval of the School Management Committee or the process prescribed by the appropriate government under any circumstances.
- The acts and regulations of the central and state governments enacted/framed in connection with regulation of fee in respect of the various categories of the schools situated in the state will be applicable to our school too.
